Call to Order and Announce a Quorum is Present

(Agenda Item 1)

Chairperson Sarah Hicks called a quorum at 5:30 p.m. Attendees were Board members Jennifer Austin, Michael Gortz, Jennifer Linde, Nicole Franczvai, and Christi Martin. Also in attendance were Arts Center Manager Denise Helbing, Arts Administration Assistant Shannon Fernandez, and Administrative Assistant Konni Cooper.

Review and Approve the Minutes of the March 21, 2023 Meeting

(Agenda Item 2)

Board members reviewed the minutes of the March 21, 2023 Arts Advisory Board meeting.

**MOTION:** Nicole Franczvai a motion to accept the minutes of the March 21, 2023 meeting. The motion was seconded by Jennifer Austin and passed unanimously.

(Agenda Item 3)

Todd Bressi, of Todd Bressi and Associates, attended the meeting virtually. He introduced himself and his role in creating a new public art master plan for the city of Lewisville. See attached for the goals, methodologies, and outcomes/deliverables that Mr. Bressi outlined in the meeting. Mr. Bressi also asked the board for their thoughts and questions. The following points were mentioned:

- How do we determine if the board is on the same track as the community?
- Can we have more public participation in the creation of public art?
- How can we utilize more local resources and talent?
- How can we show the community that public art is important to Lewisville?
- How can we help the community understand that funding for the arts isn't being siphoned from other important city-funded departments and projects?
- How can we make the youth in Lewisville more aware of public art?
- How can we use public art to create an identity for Lewisville?
- How can we develop a cohesive vision, given the diversity in our city?
- How can we create public art that will be visible at all gateways to the city, and not just along IH-35?
- What role will art play in tying together Lewisville and Castle Hills?
- The Parks and Recreation Department has a goal of creating enough parks so that no one in the city will ever be more than a ten-minute walk from one of its parks. Can we do something similar with public art?
- Can we make LLELA more of a focus for public art?
- Can we make public art more interactive?
- Can we utilize public art to honor first responders and others?
- How can we expand public art beyond Old Town?
- How can we identify more opportunities for private and public art partnerships (especially with murals)?

Mr. Bressi asked the board to consider which was more important, fixing processes, or focusing on specific projects in the coming years. The board members expressed that both were important. Mr. Bressi also left the board with a list of "homework" questions.

- What projects have been most successful? Why?
- What projects have been least successful? Why?
- What aspects of the process are working well?
- What aspects of the process need to be improved?
- What areas outside of downtown need to be a priority?

# **Chin Community Sculpture Fabrication Update with Artist Madeline Wiener**

(Agenda Item 4)

Madeline Weiner attended the meeting virtually. She showed photos of the work at the current stage of fabrication and discussed the development of the piece. The piece is in the "roughing out" stage and does not contain many details yet. The board stressed the importance of showing traditional Chin textile patterns on the large piece, as well as the smaller bench seats. Ms Wiener answered questions about the sculpture from the board.

- Metal cut-outs a joint project with the Parks and Recreation Department
- A mural program development utilizing private partners

**MOTION**: Christi Martin made a motion to allow Denise Helbing to finalize a public art work plan memo for the next budget meeting, with the four projects mentioned above. Michael Gortz seconded the motion, which passed unanimously.
